Auction Sales - Baby Emi Jewelry expressly prohibits the sale of our products on eBay or any online auction site. If our products are listed on eBay, you will be billed full retail cost of all goods listed and your wholesale agreement will be terminated.

Images and Descriptions - All images and descriptions of Baby Emi products are protected by US and International copyright laws. Upon creation of a dropshipping relationship with Baby Emi, you will be authorized to use the images and text in the promotion and sale of Baby Emi products. They may be uploaded to an online storefront, but they may not be altered in any way.

Branding - All products must be identified clearly as Baby Emi products on your site or in your retail store. You may not alter our product names or descriptions in any way.

Payment Terms - Baby Emi Jewelry requires full payment for all orders before shipment. We accept Visa, Mastercard, and Discover.

Lead Time - Since all items are custom made, please allow 2 to 3 weeks for shipment.

Shipping - All orders are shipped via USPS Priority Mail and incur a shipping and handling fee of \$10.00 per order.

Returns - Unless an item is damaged or defective, there are no refunds or returns on Baby Emi Jewelry products. You must report any shipping damages within 24 hours. After this time, you assume all responsibilities for items damaged in transit.
